Mr. Thomas entered the meeting at 10 after, in his absence, First Vice President, Ms. Haden presided over the first portion of the meeting.

Communications

During the month between Board meetings, Ms. Connelly and several Board members received letters from two patrons regarding the library's decision to remove music CDs from its physical collection. Ms. Connelly offered to meet with all members of the public who would like to discuss this direction further. She explained that CDs are difficult to purchase from the library's vendors due to scarcity.

Approval of Minutes

Upon a motion made, seconded, and ADOPTED, the Board approved the minutes of the meeting on April 14, 2025 as distributed.

Director's Report

Monday, May 12 was the first day for KCPL's new Financial Services Coordinator, Mr. Jay Raber. Ms. Connelly introduced him to the board and he was enthusiastically welcomed to the team.

The board received a full financial report in this meeting's packet that covered all transactions and account statements in the first quarter of the 2025 calendar year (from Jan 1 to March 31). She gave a brief overview of the document.

KCPL's Summer Library Club kickoff weekend will begin on Saturday, May 31. The library's Programming Manager, Mr. Ben Ball, gave an overview of featured programs for the summer. This year's theme is "Color Your World."

KCPL is observing Mental Health Awareness month in May, as part of this month's programs, the Main library's children's department hosted the Kanawha-Charleston Human Association for "Puppies and Kittens, Oh My." The three-hour program on May 6th had 86 visitors. The staff at KCHA brought adoptable animals.

Action Items

1. Approval of Update to Collection Development Policy

A special committee of the Board met earlier in the year to review KCPL's Collection Development Policy, with a particular focus on the "Request for Reconsideration of Library Materials" section. Library counsel, Mr. Chris Winton, reviewed and approved the committee's suggested document. The new policy is more consistent with the governing law. Ms. Connelly explained that the library receives around 5-6 challenges to materials each year. These are reviewed by the director and a team of three professional librarians. The following resolution was then read into record; it was approved unanimously.

APPROVED, that effective May 12, 2025, the Kanawha County Public Library ADOPTS the new Request for Reconsideration of Library Materials policy as distributed in the board packet.
